Dear Members:

Another shooting season is coming to a close, and it's time to renew for next year. More and more ranges are being closed, and a place to shoot is becoming harder to find. Value your Membership in C.D.T.S.A. There is a membership cap, so you should renew early to ensure your membership and a place to shoot.

MEMBERSHIP FEES: Unchanged for 2012

LAND ACQUISITION: We have purchased a quarter section, one hour drive South East of our present range. There is a lot of work, and a number of approvals are required, before we can use the new facility. Early 2013 is our target date.

C.F.C REAPPROVAL: We have met or exceeded all the requirements asked of us by the C.F.C.

MAGNUM CALIBERS: These can now again be discharged on the 50 / 100 yard range.

NEW RULE: SHOOTING MUST BE DONE FROM THE BENCH ONLY on the 50 / 100 yard range. No other shooting positions may be used. The only exceptions are organized matches under the direction of the Match Director. Rules for all the other ranges are the same as last year.

SIGHTING IN: Pay special attention to sighting in new rifle / scope combinations - bore sight first. We do not want our new ground baffles shot up.

RULE 13 States that there is to be absolutely no shooting into the ground baffles or shooting objects off of the top of the baffles.

RENEWALS: You are reminded that renewals must be received by January 31st 2012 if you want to guarantee membership in C.D.T.S.A. After the 31st of January, memberships will be on a first come - first serve basis up to our membership cap.

Part of your Executive's responsibility is to provide due diligence for matters which may affect our organization and any of its operations. One of the conditions of operating our range is that members possess a valid firearm license. **We therefore require that you include a legible photo copy of your firearms license for our records when you submit your renewal.**
